Terms of Use

Privacy Policy

This Privacy Policy governs the manner in which Joint Base Charleston collects, uses, maintains and discloses information collected from users of the JBCharlestongolf.com website. This privacy policy applies to the Site and all products and services offered by Joint Base Charleston.

Personal identification information

We may collect personal identification information from Users in a variety of ways, including, but not limited to, when Users visit our site, register on the site, subscribe to the newsletter, respond to a survey, and in connection with other activities, services, features or resources we make available on our Site. Users may be asked for, as appropriate, name, email address, phone number and/or postal address. Users may, however, visit our Site anonymously. We will collect personal identification information from Users only if they voluntarily submit such information to us. Non-personal identification information
